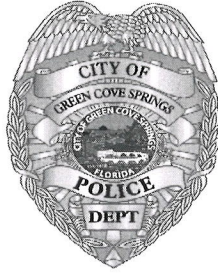

In 2021, the Green Cove Springs Police Department had a total of nineteen (19) Supervisor Reviews (SRs) and three (3) Internal Affairs Investigations (AIs).

Out of fifteen Supervisor Reviews, two (2) were closed "Exonerated", ten (10) were "Sustained", four (4) were "Unfounded", two (2) resigned before completion and one (1) was "Not-Sustained."

As of this date, there are four (4) Supervisor Reviews not completed due to resignation and one (1) active Internal Affairs Investigation.

The most serious allegation from 2021 was Untruthfulness (Sustained).  
The least serious incident was a Minor Policy Violation (Unfounded).

It should be noted that most of the Supervisor Reviews in 2021 were initiated internally; mostly the same 3 members filing against each other. One of those members has since resigned.
